## **Terms and Conditions**

- 1. The student select a time mutually convenient to both the student and Bonalesedi, for the training.

  It is in the interest of the student to attend for at least one-hour Lesson daily or arranged by the lecturer
- 2. It is to the advantage of the student to arrive atleast 5 minutes before the start of the training session.
- 3. The date and time of rescheduled training sessions due to lateness or absence is at the sole discretion of Bonalesedi
- 4. No refunds will be made if the student withdraws or is abscent during the course of the training
- 5. If a student is unable to attend a scheduled class the lesson/s will be rescheduled at no extra cost on condition that they contact Bonalesedi at least 2 hours before the actual schedule lesson.
- 6. Bonalesedi reserves the right to reschedule any lesson at their own discretion.
- 7. Examination papers must remain at the training centre and remain the property of Bonalesedi.
- 8. Bonalesedi will not be held liable in any manner whatsoever for injury to, or death of any student, nor for loss or damage to personal effects and possessions whilst the student is on the college premises or any where else in connection with the course wheather the injury, loss or damage is a result of negligence or otherwise.
- 9. All final exams must be written within 3 Months from the date of enrolement, unless otherwise arranged with the principal of the college.
- 10. This contract may not be cancelled or transferred to another person.
- 11. Bonalesedi may from time to time make rules it consideres advisable relating to course attendance. Student conduct and other matters and the parties hereto agree to be bound by these rules.
- 12. Bonalesedi reserves the right to exclude the student from lectures for not complying with the terms and conditions of this contract or the rules and regulations of the college.
- 13. All study material remains copyright property of Bonalesedi.
- 14. The student will not be permitted to write external examinations unless entance fees are paid timeously.

  The student will not be permitted to attend classes in the event of payment terms not being complied with.
- 15. If the course fees are to be paid by way of installment, the full balance due to Bonalesedi will become immediately due and payable without notice if any one installment is not paid on the due date.
- 16. - 18. If a course is not completed within the specified period a 30% fee will be charged above the course fee for every extra month that a student takes to complete the course unless arranged by the college and will have to be settled before the final exams
